- 2. <u>Approval of Secretary's report;</u> Kyle moved to accept, John seconded, no further discussion & voted-passed

3. <u>Treasurer's Report</u>: Drew Wessell

Operating wise we are right in line with last year. We made some progress with Lions owing dues. Drew sends it all out online, no paper accts are sent out. Derek Moore put his paper in, never paid and then ghosted us. Gary stated that Derek Moore is visually impaired and has transportation issues. Drew & Jeff will work on figuring out that. What was our final cost on the bike? I know we paid for the bike? Did we get anymore donations for the bike. Tim, said to send out the link and then the gifts are all designated for the bike. Gary will send out another email to the district clubs again and see if we can get money recouped. Kyle move to accept the treasurer's report, Jim seconded, voted, passed. On a side note, Gary stated that everyone loved riding the bike and spending time with Osman. Kyle will be sure to thank Kim Gary and the committee for the Holiday Social the night of the event.

5. Vice-Presidents Report: Jim Schuyler:

Only one thing Jim had to report on was to keep in contact with Dan for a basic fundraising event at the Pickleball Club. To get all the details and then hand it off to the committee. Dan is not responding back.

- Jim was looking into turning the event into a fundraising event with All in One Pickleball. However, Dan is not getting back to Jim.
- 2. Eyeglass Recycling: Rockford is between two spots. Feeding America Building on 28th Street. They have space but the other spot is in Rockford next to All in One Pickleball. Rockford is looking into the GR Lions helping to fund some of the costs. Gary reached out to Scott Brady who knows eyeglass recycling and possibly give \$4,000-\$5,000 for the year. Then maybe have other clubs in the district to hold a meeting there. Help with recycling and then donate to the center. No one is sure if we still have money coming back from the recycling center in California. Right now we have a boxcar in GR storing glasses. - 4. Holiday Social 52 coming. Normally around 60. Cheryl sent a reminder last night. We voted to up the money for Ryan Smith to \$1,000. Rob said to keep it at \$750 and have members bring gifts. That is how the social originally got their raffle gifts.
